Quarterly Rebate Component

The Amplif-Eye™ Quarterly Rebate Component offers you the opportunity to earn a quarterly rebate based on your purchases of boxes of certain CooperVision products during the 2024 Fiscal Year. For Fiscal Quarter 2 only, earn an additional \$1.00 Per-Box Rebate on any sphere in the clariti® 1 day or Biofinity® Brand Families.

For purchases in Fiscal Quarter 2 ONLY, sphere lenses (non-toric and non-multifocal) in the clariti® 1 day or Biofinity® Brand Families will earn an additional \$1.00 Per-Box Rebate on top of the regular Amplif-Eye Quarterly Rebates. All other Terms and Conditions still apply.

Annual Participants in the Quarterly Rebate Component are eligible to earn a quarterly rebate for each Fiscal Quarter in Fiscal Year 2024 in which they meet the following qualifying Thresholds:

- Net Number of Boxes of all Product for a Fiscal Quarter in 2024 equal to or greater than the Net Number of Boxes of all Product for the same Fiscal Quarter in 2023, and
- Have a minimum of 100 Net Number of Boxes of all Products for the Fiscal Quarter.

If the above Thresholds are met for a Fiscal Quarter in 2024, Quarterly Participants will receive a Per-Box Rebate in the form of a quarterly rebate on Boxes in the specified Brand Families listed above as Rebate Earning Products.

To earn the additional \$1.00 Fiscal Quarter 2 sphere rebate incentive, a Quarterly Participant must earn a quarterly rebate in Fiscal Quarter 2. Any Diamond Tier Annual Participant that qualifies at the end of the Fiscal Year for a missed quarterly rebate for Fiscal Quarter 2 will not be credited for any additional \$1.00 Fiscal Quarter 2 sphere rebate incentive, and the missed quarterly rebate will be calculated using only the regular, Per-Box Rebate amount. For example, a qualifying Diamond Tier Annual Participant with 100-299 NNBP for Fiscal Quarter 2 will have a missed quarterly rebate on clariti® 1 day sphere calculated using a Per-Box Rebate of \$2.50 per box, not \$3.50 per box. All other Terms and Conditions still apply.

Amplif-Eye™ 2024 Quarterly Rebate Component Terms and Conditions

These are the condensed version of the Terms and Conditions for the Fiscal Year 2024 Quarterly Component of CooperVision's Amplif-EyeTM Program ("Quarterly Rebate Component"). The full version of the Terms and Conditions can be found at coopervision.com/practitioner/amplif-eyeterms.

Definitions

"Box" means an individual box of Product or Rebate Earning Product, without regard for the number of lenses in the box.

"Fiscal Quarter" means the following periods during a Fiscal Year: November 1 – January 31 (Fiscal Quarter 1), February 1 – April 30 (Fiscal Quarter 2), May 1 – July 31 (Fiscal Quarter 3), and August 1 – October 31 (Fiscal Quarter 4).

"Fiscal Year" means the period between November 1 of a year and October 31 of the following year. The specific year a Fiscal Year is referred to is the year in which it ends (e.g., Fiscal Year 2024 is November 1, 2023, through October 31, 2024).

"Net Number of Boxes" means the aggregate number of Boxes of Product or Rebate Earning Product purchased by Quarterly Participant during a Fiscal Quarter (either directly from CooperVision or indirectly through a CooperVision authorized distributor), less any returns, credits, or discounts. Net Number of Boxes is determined for each Fiscal Quarter separately and there is no carry-over or aggregation of Net Number of Boxes from one Fiscal Quarter to the next, unless otherwise expressly indicated.

"Per-Box Rebate" shall have the meaning given in the "Eligibility" section below.

"Product(s)" means CooperVision branded, or customer branded equivalent, soft contact lenses manufactured by CooperVision or its subsidiaries and purchased by Quarterly Participant from CooperVision or an authorized distributor, including MiSight, but excluding specialty contact lenses sold or formally sold by CooperVision Specialty EyeCare, trial lenses or any other contact lenses expressly excluded from this Quarterly Rebate Component by CooperVision.

"Qualified Location(s)" means any location or group of locations of a Quarterly Participant, owned by Quarterly Participant as of the last day of a relevant Fiscal Quarter, as determined by CooperVision.

"Quarterly Participant" means a member of a CooperVision approved Doctor Alliance, Buying Group, Franchise, Sublease, or enrolled independent location participating in this Quarterly Rebate Component, for so long as such Quarterly Participant is an enrolled independent location or member of Doctor Alliance, Buying Group, Franchise, Sublease as of the last day of the relevant Fiscal Quarter of Fiscal Year 2024, as determined by CooperVision. Any reference to "Quarterly Participant" shall, for clarity, include any Qualified Locations of such a Quarterly Participant.

"Rebate Chart" means the chart illustrating the Per-Box Rebates and Rebate Earning Products for this Quarterly Rebate Component and published by CooperVision online or in sell sheets describing the Quarterly Rebate Component.

"Rebate Earning Product" means a subset of purchased Product on which a quarterly rebate can be earned under the program described herein, comprising only those Products in the Brand Families specifically set forth in the Rebate Chart (or, for clarity, customer brand equivalents of those Brand Families).

"Threshold(s)" shall have the meaning given in the "Eligibility" section below.

Eligibility and Rebate Calculation

Quarterly Participants must be independent locations enrolled in the Quarterly Rebate Component by a CooperVision Sales Representative or otherwise affiliated with an approved Doctor Alliance, Buying Group, Franchise or Sublease that participates in the Quarterly Rebate Component. Enrollment for members of an approved Doctor Alliance, Buying Group, Franchise, Sublease participating in the Quarterly Rebate Component is automatic. Speak to your CooperVision or authorized distributor Sale Representative about any questions on enrollment.

To earn a quarterly rebate under the Quarterly Rebate Component, Quarterly Participants must have both (i) a Net Number of Boxes of all Product for the relevant Fiscal Quarter in Fiscal Year 2024 equal to or greater than the Net Number of Boxes of all Product for the same Fiscal Quarter in Fiscal Year 2023 (e.g., Fiscal Quarter 1 2024 is compared to Fiscal Quarter 1 2023), and (ii) purchased a minimum of 100 Net Number of Boxes of all Product for the relevant Fiscal Quarter in Fiscal Year 2024 ((i) and (ii) each a "Threshold", and collectively, the "Thresholds")

Notwithstanding that the Thresholds are determined based on purchases of all CooperVision Product, once the Thresholds are met, quarterly rebates are calculated and paid only on Rebate Earning Product. The quarterly rebate is calculated by first determining the per-Box rebate dollar amount (the "Per-Box Rebate") from the Rebate Chart, based on the intersection of (i) the column determined by Quarterly Participant's Net Number of Boxes of all Product for the relevant Fiscal Quarter in Fiscal Year 2024 and (ii) the row for the relevant Rebate Earning Product. The quarterly rebate is then calculated by multiplying the applicable Per-Box Rebate by the Net Number of Boxes of Rebate Earning Product for the relevant Rebate Earning Product.

Rebate Processing

If any quarterly rebate under this Quarterly Rebate Component is less than one hundred dollars (\$100), said rebate payment will not be paid, will not be carried over and will be forfeited.

Please allow up to 8 weeks from the end of the Fiscal Quarter for rebate processing.

Any claim(s) by Quarterly Participant for quarterly rebates(s) not properly calculated or distributed by CooperVision must be brought to CooperVision's attention in writing within forty-five (45) days after (i) receipt of the applicable rebate payment or credit from CooperVision or (ii) the date a rebate should have last been paid or credited by CooperVision if no rebate is paid or credited (i.e. 8 weeks after the end of the relevant Fiscal Quarter in Fiscal Year 2024). Any claim not timely brought shall be forfeited.

Forfeiture and Right to Offset

In the event that Quarterly Participant fails to pay any CooperVision invoice when due or fails to maintain all accounts with CooperVision on a current basis, CooperVision shall offset amounts owed to CooperVision with any quarterly rebate earned by Quarterly Participant under this Quarterly Rebate Component, and shall a balance still remain or such failures to maintain accounts in good standing persist, Quarterly Participant shall forfeit any continued participation in this Quarterly Rebate Component.

A violation by Quarterly Participant of any of these Terms and Conditions, including but not limited to those related to resale obligations, reasonable purchases, or any efforts to manipulate the Quarterly Rebate Component may, in CooperVision's sole discretion, result in a forfeiture of any rebate(s). If a quarterly rebate has already been paid during any period when these Terms and Conditions were violated, or that was not earned before CooperVision discovered the violation, improper payment or declared a forfeiture, Quarterly Participant shall immediately repay the rebate amount to CooperVision, or in the alternative, CooperVision shall collect such amount by offsetting against any future amounts owed Quarterly Participant (under this Quarterly Rebate Component or otherwise) and reserves the right to take any other action to collect such amount.

A change in ownership of a Quarterly Participant, as determined by CooperVision, prior to the last day of an applicable Fiscal Quarter in Fiscal Year 2024 shall result in a forfeiture of the prior owner's receipt of any quarterly rebate for the Fiscal Quarter, even if ownership existed for a portion of the Fiscal Quarter.

Quarterly Participant will be ineligible for this Quarterly Rebate Component in the event that Quarterly Participant becomes eligible for and elects to participate in an alternate CooperVision rebate program.
